- 1.4. The Organiser reserves the right to cancel, modify, suspend, delay, or amend the Contest Terms and Conditions at any time without prior notice
- 1.5. The Organiser is not and shall not be held responsible for any technical malfunction in connection with the Contest
- 1.6. All decisions from the Organiser on all matters relating to the Contest is final and no further correspondence will be entertained
