

HOMEDec TAG, SUBMIT & WIN CONTEST (HOMEDec KL EDITION) TERMS & CONDITIONS

By registering or taking part in the HOMEDec TAG, SUBMIT & WIN CONTEST herein (the “Contest”), all persons participating herein (the “Participants”) agree to be bound by the Terms and Conditions as listed below;

1. CONTEST PERIOD

- 1.1 The Contest period for the HOMEDec KL Edition will run from **17 Feb – 11 Mar 2025**
- 1.2 The Contest Submission Deadline ends on **11 Mar 2025 (Tuesday) at 6.00pm**. All participation or entries received after the date and time stated shall not be entertained and will be deemed invalid and immediately disqualified
- 1.3 The Organiser reserves the right to shorten or extend the Contest period without prior notice
- 1.4 The Organiser reserves the right to cancel, modify, suspend, or amend the Contest Terms and Conditions at any time without prior notice
- 1.5 The Organiser is not and shall not be held responsible for any technical malfunction in connection with the Contest
- 1.6 All decisions from the Organiser on all matters relating to the Contest is final and no further correspondence will be entertained

2. CONTEST ELIGIBILITY

- 2.1 The Contest is open to all Malaysian residents aged 18 years old and above at the time of the Contest
- 2.2 Employees of the Organiser and its Affiliates, Sponsors, Agencies, Contractors, Suppliers, Exhibitors, and their immediate Family members are not eligible to participate

3. CONTEST CRITERIA AND MECHANICS

- 3.1 A total of **TWO (2) FACEBOOK Posting** would be published by the Organiser on the HOMEDec Official Facebook Page.
- 3.2 All participants are required to:
 - 3.2.1 **“LIKE”** the HOMEDec Official Facebook Page
 - 3.2.2 **“SUBMIT”** their home layout plan by sending a message to the HOMEDec Official Facebook Page
 - 3.2.3 **“SHARE”** any (either one of the TWO (2) and/or ONE (1) of and/or ALL) of the Contest posts
 - 3.2.4 **“TAG”** THREE (3) friends in the comment section of the Contest post(s) and;
 - 3.2.5 Set their Facebook feed or profile to **“PUBLIC”**

- 3.3 Each Participant may submit an unlimited number of entries as long as the Contest criteria mentioned in 3.2 – 3.2.5 is fulfilled before the end of the submission deadline. However, regardless of the number of entries in any of the TWO (2) Contest posts published by the Organiser, only ONE (1) winner will be selected for each prize

- 3.6 The Organiser reserves the right to disqualify the Participants and/or revoke the prize at any stage of the contest if:
 - 3.6.1 There is any discrepancy in the Participants eligibility or does not meet any of the Contest criteria
 - 3.6.2 The Participant breaches the Terms and Conditions or other rules and regulations of the contest
 - 3.6.3 At the Organiser’s sole discretion, it believes that the Participants have attempted to undermine the operation of the Contest by fraud, cheating, or deception
 - 3.6.4 Whilst the Organiser will endeavour to conduct necessary verification on the eligibility of the Participant, failure to disqualify any ineligible Participant shall not be deemed a breach by the Organiser

The Organiser shall not be obliged to give any reason or enter into any correspondence with any person on any matter with regards to the Contest nor the reason of how and why a Participant is chosen as the winner

- 4.4 All winners are required to respond within the same day on **12 Mar 2025, 8 pm** via a private message on Facebook Messenger through the HOMEDEC Official Facebook Page no later than the above-mentioned date and time to arrange the logistics for their prize redemption

- 4.5 If the Organiser does not receive a response from the Winner by the response deadline, the original winner will be forfeited and the Organiser remains the right to select another winner without prior notification

- 4.6 All prizes must be collected personally by the winner in **HOMEDEC KL** at the **KUALA LUMPUR CONVENTION CENTRE** between **13 Mar – 16 Mar 2025** during its operating hours between **10am – 8pm**.
