

HOMEDEC CONTEST – SHOP BIG WIN BIG! TERMS & CONDITIONS

- 1.2. All participation or entries received after the date and time stated shall not be entertained and will be deemed invalid and immediately disqualified
- 1.3. The Organiser reserves the right to shorten or extend the Contest period without prior notice
- 1.4. The Organiser reserves the right to cancel, modify, suspend, delay, or amend the Contest Terms and Conditions at any time without prior notice
- 1.5. The Organiser is not and shall not be held responsible for any technical malfunction in connection with the Contest
- 1.6. All decisions from the Organiser on all matters relating to the Contest is final and no further correspondence will be entertained

2. CONTEST PARTICIPATION & ELIGIBILITY

- 2.1. The Contest is open to all Malaysian residents aged 18 years old and above at the time of Contest
- 2.2. Employees of The Organiser and its Affiliates, Sponsors, Agencies, Contractors, Suppliers, Exhibitors, and their immediate family members are not eligible to participate
- 2.3. All participants are required to present a proof of purchase to qualify for the Contest. Each proof of purchase presented by the Participant will only be recognised as one (1) registered participant

- 2.5. The cut-off time for all the Contest submissions is at **8.30pm, daily from 6 9 November 2025.**

During which, the qualified winners are required to send a private message on the HOMEDEC Facebook Page to arrange for the collection by 12pm on the following day. An attempt will also be made by the Organiser to contact the winner to arrange for the prizes for redemption
- 2.6.5. Failing which, where the Participant does not reply and/or cannot be contacted, the Organiser reserves the right to disqualify their winnings and forfeit their prizes and as such, the uncollected prizes will be rolled over to the next day for the next qualifying winner
