

TAG, SHARE & WIN CONTEST
(HOMEDEC PENANG EDITION)
TERMS & CONDITIONS

By registering or taking part in the HOMEDEC TAG, SHARE & WIN CONTEST herein (the "Contest"), all persons participating herein (the "Participants") agree to be bound by the Terms and Conditions as listed below;

1. CONTEST PERIOD

- 1.1 The Contest period for the HOMEDEC Penang Edition will run from **21 March – 9 Apr 2026**
- 1.2 The Contest Submission Deadline ends on **9 Apr 2026 (Thursday) at 10.00PM**. All participation or entries received after the date and time stated shall not be entertained and will be deemed invalid and immediately disqualified
- 1.3 The Organiser reserves the right to shorten or extend the Contest period without prior notice
- 1.4 The Organiser reserves the right to cancel, modify, suspend, or amend the Contest Terms and Conditions at any time without prior notice
- 1.5 The Organiser is not, and shall not be held, responsible for any technical malfunction in connection with the Contest
- 1.6 All decisions of the Organiser on all matters relating to the Contest is final, and no further correspondence will be entertained

2. CONTEST ELIGIBILITY

- 2.1 The Contest is open to all individuals aged 18 years old and above at the time of the entry, including Malaysian citizens and non-Malaysians holding a valid passport.
- 2.2 Employees of the Organiser and its Affiliates, Sponsors, Agencies, Contractors, Suppliers, Exhibitors, and their immediate family members are not eligible to participate

3. CONTEST CRITERIA AND MECHANICS

- 3.1 A total of **ONE (1) FACEBOOK Posting** would be published by the Organiser on the HOMEDEC Official Facebook Page.
- 3.2 All participants are required to:
 - 3.2.1 "LIKE"** the HOMEDEC Official Facebook Page;
 - 3.2.2 "SHARE"** the Contest post;
 - 3.2.3 "TAG"** THREE (3) friends in the comment section of the Contest post and;
 - 3.2.4** Participants must ensure their Facebook feed or profile to is set to **"PUBLIC"** for the duration of the Contest.

- 3.3 Each Participant may submit an unlimited number of entries, provided that the Contest criteria set out in Clauses 3.2.1 – 3.2.4 are fulfilled before the submission deadline. Notwithstanding the number of entries submitted in relation to the Contest post published by the Organiser, only ONE (1) winner will be selected for the prize
- 3.4 Participant who do not meet the eligibility requirements or who are subject to any entry restrictions shall not be entitled to be selected as a winner or to receive any prizes under any circumstances
- 3.5 The Organiser’s decision in respect of all matters relating to the Contest shall be final, and no correspondence will be entertained
- 3.6 The Organiser reserves the right to disqualify the Participants and/or revoke the prize at any stage of the Contest if:
- 3.6.1** There is any discrepancy in the Participant’s eligibility or if the Participant does not meet any of the Contest criteria;
 - 3.6.2** The Participant breaches the Terms and Conditions or other rules and regulations of the Contest;
 - 3.6.3** In the Organiser’s sole discretion, it determines that the Participant has attempted to undermine the operation of the Contest by fraud, cheating, or deception; or
 - 3.6.4** While the Organiser will endeavour to carry out the necessary verification of a Participant’s eligibility, any failure to disqualify an ineligible Participant shall not be deemed a breach by the Organiser

4. CONTEST PRIZE & WINNER ANNOUNCEMENT

- 4.1 A total of THREE (3) prizes would be awarded to THREE different (3) winners. The winner will receive ONE (1) prize as specified below. The Organiser reserves the right to substitute the prize with an item of equivalent value at its absolute discretion:

- 4.2 All winners of the Contest will be announced via an Announcement Post on the HOMEDEC Official Facebook Page on **10 Apr 2026**
- 4.3 The Organiser’s decisions on all matters relating to the Contest shall be final, conclusive, and binding. The Organiser shall not be obliged to provide any reasons or enter into any correspondence with any person in relation to the Contest, including the selection of winners
- 4.4 All winners are required to respond on **10 Apr 2026 by 8 PM** via a private message on **Facebook Messenger** through the **HOMEDEC Official Facebook Page** to arrange the logistics for their prize redemption/collection
- 4.5 If the Organiser does not receive a response from the Winner by the stated deadline, the prize will be forfeited, and the Organiser reserves the right to select an alternative winner without prior notice

- 4.6 All prizes must be collected personally by the winner in **HOMEDEC Penang**, held at the **SETIA SPICE CONVENTION CENTRE** from **10 – 12 Apr 2026** during its operating hours between **11AM – 9PM**.
- 4.7 Only the winner is allowed to collect the prize. In the event that the selected winner is unable to collect the prize in person at HOMEDEC Penang, collection by a representative and/or delivery by post shall not be permitted, and the winner shall be deemed to have forfeited all rights to the prize. In such event, the Organiser reserves the right to select the next eligible winner at its sole and absolute discretion

- 4.8.2: **For Non-Malaysians:** Full name as per Passport, Passport Number, and a valid mobile phone number and email address.
- 4.9 In the event that the announced prize is unavailable, the Organiser reserves the right to substitute or replace the prize with another item without prior notice. All prizes are non-transferable, non-refundable, and non-exchangeable and are not redeemable for cash

- 5.4 A Participant may revoke his or her consent to the storage of personal data by contacting the Organiser via the HOMEDEC Official Facebook Page. Upon such revocation, the Participant shall be deemed to have withdrawn from the Contest
- 5.5 The Organiser will use its best endeavours to keep all personal data of the Participants strictly confidential, except for the names of the winners, which may be published on the HOMEDEC Official Facebook Page
- 5.6 All personal data received will be processed in accordance with the Personal Data Protection Act 2010 (PDPA)
