### Terms & Conditions

1. HOMEDEC PENANG **Register & Visit Contest** is opened to all individuals aged 18 years old and above at the time of entry, including Malaysian citizens and non-Malaysians holding a valid passport.
2. Employees of the Organiser and its affiliates, sponsors, agencies, contractors, suppliers, exhibitors, and their immediate family members are not eligible to participate.
3. This contest will be held at the **Kuala Lumpur Convention Centre**, from **30 April – 3 May 2026**. Entries must be submitted via online visitor registration. All registration forms must be completed in full, failing which, the submission will be disqualified.
4. Duplicate entries will not be accepted. Participants who have submitted the online registration form will only be eligible to win if their attendance is recorded during the exhibition period.
5. Any entries received after 3 May 2026 will be deemed null and void. The Organiser shall not be responsible for any entries that are illegible, misdirected, lost due to technical or other reasons, and/or received after the deadline.
6. A total of twenty (20) units of **Medklinn Versa U** will be given away during the exhibition period from **30 April – 3 May 2026**, with only five (5) prizes unit awarded per day.
7. Each Participant is entitled to only win one (1) prize. Duplicate entries will be disqualified.
